Bexley Music Education Hub

Bexley Music aims to enrich the lives of young people within the Borough of Bexley by providing opportunities for them to become actively involved in a wide variety of music activities.

Bexley Music is the lead organisation for the Bexley Music Education Hub which aims to ensure that all pupils have equal access to high quality music education.

We employ a team of specialised instrumental and class music teachers to deliver a wide range of musical activities who are all DBS checked and regularly monitored to ensure that delivery is of the highest standard.

We recognise and embrace the wealth of important skills and attributes that music can deliver to our young learners such as:

- Music boosts pupils' social development
- Music improves learning skills
- Music fosters team working
- Music builds life skills
- Music underpins better behaviour
- Music encourages creativity
- Music is for life
- Music is an educational building block
- Music is fun
- Music is for everyone

Music supports learners with special educational needs to develop confidence, improve coordination, develop fine motor skills and to engage in positive activities.

Principles of Bexley Music

A broad and balanced music education for all young people in school.

Music combines intellect and feeling to enable personal expression, reflection and emotional development. The need to encourage and develop musical feeling, thinking and enjoyment through participation in composing, performing and appraising (listening to and talking about) is fundamental to the work of the service.

The provision of a high-quality instrumental teaching service that promotes the value and importance of instrumental tuition. The Music Service seeks to work in close partnership with all Bexley schools to provide a service that matches their individual needs.

The provision of a broad and balanced programme of music making opportunities for young people in Bexley.

Participation in bands, ensembles, orchestras, choirs, and other music making activities supports the development of pupils' sense of achievement, self-worth, self-discipline, self-confidence and social awareness.

The ability and willingness to offer schools, pupils, parents and carers comprehensive advice about playing, maintaining and sustaining their instrumental programme.

Valuing pupils' understanding, skills, experience, and attitudes is fundamental to the work of Bexley Music.

Services that Bexley Music provides:

1. First Access Whole Class Instrumental Programmes

Bexley Music will plan and deliver first access whole class instrumental tuition to each year 4 class (or to a mixed class where vertical streaming is in operation in the school) with one teacher from the school present and participating. Whole class instrumental programmes are heavily subsidised to give schools at least 10 free lessons an academic year in line with the Arts Council England's guidelines. This must be instrumental tuition (not vocal). The hour includes set-up/liaison time of up to 15 minutes and 45 minutes of contact.

All instruments on loan remain the sole property of Bexley Music.

Please note that it is not possible to provide First Access whole class instrumental programmes to cover for PPA time. Where this is found to be happening schools will be charged the hourly rate for PPA cover.

2. <u>Clubs (Progression 2)</u>

Schools purchasing the First Access whole class provision can purchase a lunch time or after school club which will be on the instrument already being used in the classroom. This is 30 minutes or an hour in length.

3. Individual and Small Group Instrumental Tuition (Progression 1)

Bexley Music will provide individual or small group instrumental tuition for 25 weeks across the academic year. Schools can charge parents for this service (but may choose not to). Schools can make a request to extend the amount of time purchased at any point during the academic year. Schools should be aware that where increased demand cannot be met from within existing staffing, there may be a delay to allow us to complete pre-employment checks for new Music Educators.

The range of instruments currently taught includes:

- Upper strings (violin and viola)
- Lower strings (cello and double bass)
- Woodwind (Reed allowance may be payable)
- Brass
- Guitar/ukulele
- Keyboard/piano
- Recorder
- Percussion/Drum kit

Other instruments may be available on request – specific requirements should be discussed with Bexley Music.

4. <u>Curriculum Teaching</u>

Bexley Music can provide a qualified teacher to provide curriculum music lessons for the full 38 weeks of the academic year. This can be used as PPA cover and the classroom teacher does not need to be present. (TAs need to be in place as per usual).

- 5. Specific whole class or small group projects planned in partnership with the school, paid for by the school.
- 6. All young people in the Borough of Bexley are welcome to access music groups and individual /paired lessons at Bexley Music (price list attached).
- 7. Where appropriate, instrumental teaching can lead to performance exams. Bexley Music offers external examinations which pupils receiving tuition with Bexley Music can take. This may be 'Music Medals' but Bexley Music also enters pupils for ABRSM and Trinity/Guildhall public examinations, for which parents will be required to pay an entry fee.
- 8. Bexley Music can provide experienced musicians to run or assist in the running of school bands, orchestras, and choirs. This can be done during lunchtimes or after school as well as during curriculum time.
- 9. Whichever option is purchased all pupils are encouraged to use the Music Service by becoming involved in one of the many musical groups available at Bexley Music. These ensembles are for a diverse range of instruments and are for all standards and abilities.
- 10. Bexley Music can provide instruments to pupils through their hire scheme (subject to availability). Bexley Music will charge parents directly for instrument hire schools do not need to include this in their charges.

Responsibilities of Bexley Music to the School:

- 1. Provide suitably qualified staff to undertake music tuition.
- 2. Ensure that all Bexley Music staff have current enhanced DBS disclosures and undergo safeguarding training.
- 3. Link programmes to relevant school projects if required.
- 4. Develop progression pathways beyond first access tuition in partnership with the school.
- 5. Provide a link for each school for on-going communication.
- 6. Keep records of pupil progress and provide feedback, both to the school and to parents through annual reports.
- 7. Provide performances for the parents and other children of the school when requested.
- 8. Liaise with the music co-ordinator to discuss plans and options for tuition
- 9. Liaise with the school to plan timetables, keep registers and inform the school of any absences and endeavour to place a cover teacher into the school.
- 10. Liaise with the school in the selection of pupils for tuition.
- 11. Make every effort to accommodate all requests for tuition

Bexley Music's commitment to protecting your personal data:

Bexley Music is committed to protecting and securing any personal data that we collect and which we require to facilitate the services, transactional activities and support products that we provide to our schools. We take the protection of your personal data very seriously and adhere to current Data Protection regulations including the GDPR.

Where did we get your data from?

You provided us with the personal data we hold.

What is the legal basis and purpose for our holding your personal data?

The Personal Data we hold, and process is necessary for the performance of the employment contract to which you are party, and for Bexley Music to fulfil its responsibilities outlined in the section above (see 'Responsibilities of Bexley Music to the School').

To help us maintain a high quality of service, the school's responsibilities are:

- 1. Provide a teacher to actively participate in whole class programmes (this would preferably be the class teacher for CPD purposes)
- 2. Provide a suitable room to undertake tuition, which should be available at the same time every week and which complies with Health and Safety regulations
- 3. Provide Bexley Music teachers with relevant information about pupils which may affect their tuition, such as special educational needs.
- 4. Provide Bexley Music teachers with relevant information about school policies and procedures, for example fire drill and safeguarding procedures and behaviour management strategies
- 5. Utilise and value pupils' musical skills in school and provide performance opportunities for children involved in whole class programmes and instrumental tuition.
- 6. Provide adequate safe storage for the instruments.
- 7. Provide information to Bexley Music about children receiving tuition to enable the completion of monitoring returns to funding organisations.
- 8. Be responsible for collecting fees from parents where a decision has been taken to recharge parents for tuition.
- 9. Commit to a minimum amount of purchased time in advance (one term for Progression 1 and an academic year for First Access). Extra time can be purchased if there is an expansion of tuition in the school.
- Give adequate notice should any event or circumstance prevent the delivery of the lesson.
 Failure to do this would incur a charge for the lesson (2 weeks' notice required). Every effort will be made to reschedule cancelled lessons if possible if required notice is given.
- 11. Reduction of teaching time: Notification of a reduction in teaching time for small group/individual teaching or other regular teaching, should be given in writing to the Bexley Music office, giving notice of half a term (5 weeks). If Bexley Music is not notified of a reduction of time, 5 weeks' fees are payable in lieu of notice. Bexley Music recommends that schools set similar notice periods for parents when charging for tuition to ensure that costs are covered. Where a pupil leaves without giving the school the required notice it may be possible to substitute another pupil after these dates, provided that any new grouping of pupils is educationally sound, and the substitution does not result in a reduction of teaching time at the school.

12. Unplanned school closure: where the school has to be closed for circumstances that are out of the school's control and the school is unable to give at least 2 weeks' notice, for example due to bad weather, Bexley Music will endeavour to make up the lesson missed.

Covid-19 Risk Mitigation Summary (from Covid-19 RAs)

- 1. Teachers will wear masks in corridors and any communal areas and when possible in the lessons (only removing if the instrument demands it for demonstration etc) They will comply with all schools' policies and procedures whilst on the school's premises
- 2. All lessons will take place in a ventilated room with windows
- 3. Bexley Music teachers have all attended training on Covid-19 risk mitigation when teaching a musical instrument and will apply all measures while following our risk assessments as well as the schools'.
- 4. Pupils should arrive for lessons punctually; this may take prompting from the school staff or a device such as a phone/ walkie talkie to be given to the music teacher to call for the pupil. This limits the need for the visiting teacher to walk around the school.
- 5. Music Service staff will wipe down any surfaces touched during lessons and use hand sanitiser frequently.
- 6. We have purchased **bell caps** for all brass and woodwind players and are offering them at a subsidised cost of £3.00 each. These have been proven to reduce aerosols emissions by 70% and are an essential part of our Covid-19 risk mitigation plan. The bell cap will become the property of the student. They are fully washable, and it is advised that they are washed regularly and in advance of each lesson. The £3.00 charge per woodwind/brass pupil will be added to the schools' invoice. This needs to be considered when calculating lesson costs.
- 7. Pupils should bring their own music to lessons, which will not be shared with anyone.
- 8. Pupils should bring a notebook and pen in which they will write notes from the teacher.

Covid-19 Contract and Payment Information

In the event of an increase in Covid-19 restrictions (including self-isolation (student and/or teacher), national/local lockdown etc.), whereby face-to face lessons are no longer possible:

- Online provision will immediately be made available. This may include live online lessons (from another room in the school, separate from the classroom or from an alternative location or to a pupil's home), the production and provision of videos for curriculum music, the provision of alternative curriculum materials etc.
- Bexley Music will work closely with schools on a case-by-case basis to ensure that the delivery contract for which the school has been invoiced is fulfilled, which may include a blended mix of face-to-face and online provision. It is not expected that refunds will be requested or made for First Access or PPA. This is in line with the DfE Procurement Policy Note (PPN).
